#### ITEM 4 - VICE CHANCELLOR'S REPORT

- 7 The Vice Chancellor, Prof David Lloyd, introduced his written report, which was taken as read, by drawing members' attention to discussions on the creation of a new university in South Australia. Prof Lloyd reported that in the context of the State Government's higher education policy, including a proposed Merger Commission, and following deep deliberation by the respective Councils, through an historic agreement and a Statement of Cooperation with the State and Commonwealth governments, the two universities had committed to explore how their combination might bring together the best of their long and proud histories with an ambitious vision for enhanced future impact. The University of Adelaide and UniSA and their respective experiences, traditions and histories had served the state exceptionally well as great South Australian institutions. However, the two institutions were now actively exploring the creation of an outstanding comprehensive world-class university that tackled global issues with local importance. Discussions had been constructive, collegial, and open and a Vision Statement for a South Australian University of the Future would be released at the end of March. Due diligence was currently being undertaken as part of a broader feasibility assessment to support consideration of future moves by the governing Councils in June 2023. A series of Town Halls would be held in coming weeks at all UniSA campuses, including at Mount Gambier and Whyalla as part of an ongoing consultation process.
- 8 Prof Lloyd also acknowledged Prof Esther May, who was Pro Vice Chancellor: Teaching and Learning, for stepping into the role whilst the Provost and Chief Academic Officer was involved in discussions on the creation of a new university.

### 5.3.1 NEW PROGRAM – GRADUATE CERTIFICATE IN CHILDHOOD TRAUMA (UNSTARRED ITEM)

9 Members noted that at its meeting held on 10 March 2023, Academic Strategy, Standards and Quality Committee (ASSQC) had endorsed the following new program proposal in accordance with the University's Program Development Procedures, while noting further information provided in relation to course details for the Capstone course, the rationale for the exception to Policy A13 Recognition of Prior Learning, information on the program's proposed future delivery through UniSA Online, and the proposed fee structure:

#### UNISA JUSTICE AND SOCIETY

#### Graduate Certificate in Childhood Trauma

- 10 The Deputy Director of the Australian Centre for Child Protection (ACCP), Ms Amanda Paton, introduced the proposed new Graduate Certificate in Childhood Trauma. She reported that the Graduate Certificate would be the first of its kind in Australia and was based on the considerable success of the Professional Certificate short course series on child trauma developed by the ACCP. This offering was aimed at upskilling current professionals or those looking to advance their knowledge in this specialised area and built directly on the professional certificate short courses which had been proving popular in the sector. The program comprised four new courses which stacked further knowledge on the existing material from the short course series. It would be delivered initially online, part-time only, with intakes in Study Period 1 and Study Period 4. The key stakeholders, the Western Australian Department of Communities, and the South Australian Department of Child Protection had both confirmed their ongoing support for the short courses and for this proposed Graduate Certificate program. These agencies had also confirmed funding for 30 students to commence in the Graduate Certificate program for an intake in Study Period 4, 2023. As such, UniSA Justice & Society was seeking approval of this new program out of standard timelines to facilitate this commencing cohort.
- Members noted that following consultation with Student and Academic Services (SAS) the Academic Unit had developed a defined pathway for the large number of students who had already completed one or more of the associated child protection short courses to gain credit through micro-credentialling into the proposed program. The stackability of the Graduate Certificate in Childhood Trauma would be attractive to both industry and professionals, enabling them to complete modules and short courses, building up to the completion of a postgraduate award. As part of this proposal, the Academic Unit was seeking approval of an exemption to the A-13 Recognition of Prior Learning policy, to grant no more than 75% credit of associated short courses, which were in essence nested academic content, into the Graduate Certificate.
- It was further noted that information requested by ASSQC had since been received. This included a new Course Statement for the Capstone Course. A statement making it clear that the intention was that students who had completed three UniSA Professional Certificates would be afforded the option of completing a 9-unit Capstone course to meet the full requirements of the new program. Subject to the satisfaction of the Director of UniSA Online and the Executive Dean, with risk mitigation, enrolment screening, as well as specialist delivery and staffing expertise requirements, the Graduate Certificate would move to the UniSA Online platform by late 2023. In relation to the proposed price point/s the Graduate Certificate would be set at a commercially advertised price of \$12,500, while a subsidized fee of \$8,514 would be made available to WA and SA Child Protection Department industry partners. This was consistent

with the original intended fee structure and would make the program more financially sustainable.

The Executive Dean of Justice and Society, Prof Paula Geldens, commended the Australian Centre for Child Protection for their support, and thanked Ms Amanda Paton in particular, and the exceptional team for their extraordinary work in developing the new Graduate Certificate program. Members of Academic Board also welcomed the new program which they believed would provide accessible high-quality training in a field much in need of further learning opportunities.

#### 6.3 RANKINGS STRATEGY UPDATE 2023

- The Dean of Graduate Studies, Prof Sandra Orgeig, reported on progress against UniSA *Rankings on a Page Strategy* (RPS), which aimed to improve the University's research standing in the Quacquarelli Symonds (QS), Times Higher Education (THE) and Academic Ranking of World Universities (ARWU) rankings. The two rankings' indicators identified as a potential focus for improvement at UniSA by Research Leadership Committee (RLC) in 2020 continued to be a priority for the University. Firstly, reputation, with suggested initiatives in the areas of marketing, visiting fellowships, adjunct policy and procedures, and support for prestigious prize nominations. Secondly, citations, with suggested initiatives in the areas of measures of success, academic promotion materials, international collaborations, and dissemination and communicating impact. In alignment with UniSA KPIs, the University was strengthening its international rankings performance. A range of ten initiatives was underway, from prioritising research-intensive recruitment in areas of strong rankings performance aligning with the University's key programs to ensuring its research could be located and attributed correctly to UniSA.
- Prof Orgeig noted that UniSA was moving in the right direction in rankings with improvements in underlying indicators during 2022, trending up in citations and HDR completions. QS and THE were updating their methodologies increasing weightings for international collaboration, graduate outcomes, sustainability, and patent citations whilst reducing the influence of highly-cited and kilo-author papers on citation metrics. UniSA's strategy would not change due to ranking methodology changes and the gap analysis from last year is still relevant. However, from 2023 we would roll out new international collaboration indicators to the R&E indicator set. This would indicate how UniSA would perform in the new ranking metric. Excellent engagement from the Academic Units providing QS ranking survey nominees was evident-more names than last year, and the focus had been on the quality of the relationship. UniSA had also engaged QS and THE to assist in communicating and raising UniSA's profile. UniSA had recently subscribed to Elsevier's SciVal platform which provided data to the QS and THE rankings. This complemented our existing subscription to Clarivate's InCites platform which provided data for ERA and ARWU rankings.
