### **Notice of Preclusion**

As we have communicated previously, we monitor academic progress regularly via the Academic Review process to help you succeed in your program.

For <Academic Review Period>, you have been identified as making unsatisfactory progress in the program <Program Name> due to: <the below list is dynamic and will update based on why the student has been notified>

- Failed 50% of your courses in this review period and/or
- Failed a course(s) for a second time and/or
- Failed a practicum or clinical placement and/or

# How does this impact my studies?

You will now be precluded from further study as you have failed to progress in your studies for three or more review periods.

- · your enrolment in your program will be discontinued
- you will be prevented from studying in this program, or a program in the same discipline, for the next two years
- application for re-admission will follow normal procedures and is not guaranteed

### Please be aware that:

- if you are a domestic student, if you gain re-admission you will be classified as a new student for the purposes of assessing fees or eligibility for Commonwealth support or assistance.
- if you are an international student, preclusion from your program constitutes a breach
  of your student visa. If you are precluded, the University is required by law to notify the
  Department of Home Affairs. This results in cancellation of your Confirmation of
  Enrolment (CoE) and may affect your student visa.

### What do I do next?

You do not need to take any further action if you accept the outcome. From **<PAC Appeal Due Date>**, any courses you are currently enrolled in will be dropped and you will be withdrawn from your program.

If you feel you have grounds to appeal the decision to preclude you from your program, you may appeal. Before preparing your appeal, please read the article **How do I appeal my preclusion**.

### Important information

- If you have grounds to appeal, you have 20 working days to lodge your appeal. You
  must lodge your appeal no later than close of business <PAC Appeal Due Date>. If
- you are a domestic student, you may continue your studies while your appeal is being considered.
- If you are an international student:
  - as a condition of your student visa, you are required to maintain satisfactory
    academic progress and attendance. This means you must continue your studies
    while any appeal is being considered.
  - o the University is obliged to maintain your CoE while any appeal is ongoing.
- If your appeal is unsuccessful, or you choose not to appeal within this timeframe, you will be precluded.
